In such case the jurisdiction and venue for actions related to the subject matter hereof are the State of California and United States federal courts located in Santa Clara County, California, and both parties hereby submit to the personal jurisdiction of such courts.

- c) Waiver and Severability of Inventor Terms. The failure of Inventor to exercise or enforce any right or provision of these Inventor Terms shall not constitute a waiver of such right or provision.
